



CHANGEMAKERS 2022.23 REQUEST FOR PROPOSALS

THE CHANGEMAKER FUND:

The Changemaker Fund offers one-year unrestricted awards of twenty-five thousand dollars to BIPOC-led community-based organizations throughout the Capital Region.

The guiding principle behind the Fund is our belief that those most impacted by a problem are in the best position to determine the solutions. Changemakers are organizations whose work addresses wide-ranging systemic inequities, including mental health, women and LGBTQ rights, food security and sovereignty, housing, youth and child success, and economic wellbeing.

We believe that supporting and strengthening BIPOC leadership is one of the most effective means to create needed social change. We prioritize organizations that are led by and center the leadership and agency of Black communities, Indigenous communities, and communities of color that approach their work using anti-oppression values: consciously striving to dismantle systems of oppression and the legacies of white supremacy culture in this country, while moving toward a more just and equitable society.

In addition to an unrestricted financial award, Changemakers are invited (not required) to participate in a co-designed facilitated leadership cohort. This includes one-on-one leadership coaching and interactive group coaching, designed to empower, and connect leadership within and across organizations and within communities.

We believe in mutual learning with awardees. Awardees will come together with team members from United Way and Healthy Alliance for three 3-hour in person co-designed sessions over the course of a year to discuss challenges and collectively brainstorm solutions to impact broad systems change. These sessions will be awardee-led with an external facilitator.

POOLED FUNDING:

The Changemaker Fund is an example of collaborative pooled funding, designed to increase the impact and scale of giving. By promoting collaboration across the philanthropic sector, Healthy Alliance and United Way are working to address resource gaps and reduce the burden of multiple applications and reporting requirements for awardees, making it possible to more meaningfully target systemic problems.





EVALUATION PROCESS:

Awardee selection is a peer review process led by former awardees, leaders who identify as BIPOC and whose organizations address the same wide range of solutions and challenges as applicants. Selection is based on the intended criteria.

Each question in the application is weighted for a total of 100 points. To increase transparency, evaluations points are made public to all applicants as part of the RFP. Applicants, please take note of point value as you assess how much time to spend on each question.

GENERAL ELIGIBILITY REQUIREMENTS:

- An organization that is led by a person who identifies as Black, Indigenous, Person of Color;
- 501c3 or community-based organization with a fiscal sponsor;
- Annual operating budget of under \$350,000;
- Operating in one or more of the following counties: Albany, Columbia, Greene, Montgomery, Saratoga, Schenectady, Schoharie, Rensselaer;
- Priority will be given to those who have not previously participated in the Changemaker Fund
- Response to RFP must be submitted no later than 11:30pm on 10/3/2022. All applications must be submitted via the United Way's online grant portal.
- The grant period is from January 1, 2023-December 31, 2023.

- Dates for 3 learning sessions to be finalized with awardees once selected.
